WHEREAS, the Village of Wales Plan Commission hereby intends to recommend adoption of the 2030 Comprehensive Plan pursuant to Wisconsin Statutes Section 66.101.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Village Plan Commission for the Village of Wales, Wisconsin, that the 2030 Comprehensive Plan attached hereto and incorporated herein by reference is hereby recommended for adoption.

BE IT FURTHER RESOLVED that action taken by the Village of Wales Plan Commission is recorded on the adopted Comprehensive Plan by the identifying signature of the Secretary.
